





MEMORANDUM OF UNDERSTANDING
between
UNIVERSITY OF BURGUNDY (FRANCE)
and
STATE INSTITUTION “LUHANSK TARAS SHEVCHENKO
NATIONAL UNIVERSITY” (UKRAINE)

University of Burgundy (uB) and State Institution “Luhansk Taras Shevchenko National University” (LNU) are exchanging this agreement to develop a spirit of amity and cooperation with each other.

1. This agreement aims to promote international academic cooperation and the exchange of teaching and research experiences between University of Burgundy and State Institution “Luhansk Taras Shevchenko National University”.
2. The two institutions will cooperate in developing friendship and mutual interests on a reciprocal basis of respect for the independence and equal status of institution.
3. The two institutions agree to:
 - a. exchange academic materials and information;
 - b. mutually receive educational visits by faculty members and researchers;
 - c. exchange students;
 - d. hold joint international conferences;
 - e. conduct joint research projects;
 - f. engage in other activities to better enhance mutual understanding and cooperation.
4. The details of this agreement are to be decided by more specific agreements after consultation between the two institutions.
5. This agreement will be effective by the signature of one or more specific agreements. It may be revised with the consent of both institutions, or terminated at the initiative of any institution with a written notice at the latest by January 31 for a termination at the end of the current academic year.
6. If any question or situation should arise which is not expressly provided for in this MOU, the same shall be resolved by consultation between the institutions in the spirit of mutual consultation and cooperation.
7. This agreement is executed in English in two originals and each institution will retain one original.

ANNEX #1
to Memorandum of Understanding between
University of Burgundy (uB)
and
State Institution “Luhansk Taras Shevchenko National University” (LNU)

According to the Memorandum of Understanding signed between the University of Burgundy (uB) and State Institution “Luhansk Taras Shevchenko National University” (LNU), both institutions decide to cooperate to **implement student and staff exchanges**, possibly in all the fields of studies offered in the two universities.

STUDENT MOBILITY

Each institution could receive up to **10 students** from the partner university per year.

At uB, LNU students will mainly attend courses offered in English for a duration of one or two semesters on Bachelor or Master level. They are also allowed to follow some extra French language modules. Alternatively, if the students can attest a B2 level in French, they can attend courses offered in French for one or two semesters on Bachelor or Master level.

At LNU, uB students will mainly attend courses offered in English for a duration of one or two semesters on Bachelor or Master level.

These students will pay their tuition fees in their home institution and will be free of fees in the host institution but they will be responsible for the room and board fees, including the Medical Insurance and local civil Liability Insurance.

Depending on possibilities, the host institution will provide assistance regarding accommodation in student residence.

STAFF MOBILITY

Each institution would facilitated staff exchanges for short periods (few days or few weeks) or as long as a full academic year. The Host university will provide appropriate working conditions and privileges, necessary for research, teaching or training

Joint research projects involving faculty members of both institutions may be implemented after the plan of execution and costs of any proposed projects are fully deliberated by and an agreement is reached between the two parties.

DURATION OF THE COOPERATION

This Annex is effective for 5 (five) years effective beginning with the academic year 2023/24. It may be revised with the consent of both institutions, or terminated at the initiative of any institution with a written notice at the latest by 31st January for a termination at the end of the

current academic year. Any termination must take into account the right of students already participating or accepted in the exchange program to complete it.

This Memorandum is written in English. It is drawn up in duplicate with a corresponding copy for each party and signed by the legal representatives.
