#### Memorandum

on cooperation between EIDE and the State Institution Luhansk National University Taras Shevchenko

#### 1. GENERAL PROVISIONS

This memorandum of cooperation (hereinafter referred to as the Memorandum) defines the relations and directions of cooperation between EIDE (Luxembourg), in the person of the director Yannick Loiseau, which operates on the basis the charter, and the State institution "Luhansk National University Taras Shevchenko" (Ukraine, Poltava, Kovalya St., 3), in the person of the rector Olena KARAMAN, acting on the basis of the Statute, are collectively referred to as the Parties, and individually as the Party.

The parties steal this Memorandum, based on the fact that informational, consulting, scientific and practical activities in the field of implementation of European standards in the education system of Ukraine is an actual and multi-component process and has an important task - the implementation of world practices of training specialists in the field of education, the study of experience regarding the possibility use of tools to support the mobility of scientists, career development, exchange of best practices, project approach in the organization of work of educational institutions.

# 2. DIRECTIONS OF COOPERATION OF THE PARTIES

- 2.1 For the implementation of this Memorandum, the Parties define the following areas of cooperation:
- 2.1.1Conducting joint events (seminars, trainings, lectures, conferences, etc.), informational and advisory work among students, teachers, scientists, representatives of the educational environment and surrounding institutions with the aim of obtaining and spreading global experience in this field.
- 2.1.2 Development and implementation of training, informational programs and courses in the format of obtaining postgraduate education together with partners, various projects with the aim of obtaining advanced European experience.
- 2.1.3 Organization of consultation of representatives of the academic environment and scientists for the exchange of experience through video conferences, organization of familiarization visits and relevant structures on the territory of the EU.
- 2.1.4 Any other forms of cooperation agreed upon by the Parties.

### 3. MUTUAL OBLIGATIONS

Any activity within the framework of this Memorandum on the territory of Ukraine is regulated by the relevant Memorandum, the legislation of Ukraine and

other documents agreed by the Parties. The parties interact on the principles of equality, openness and benevolence.

The parties interact with each other on matters of implementation of the points of this Memorandum through the authorization of representatives delegated by the parties to consider current issues and conduct joint activities. The parties agree that the terms of this Memorandum are not confidential and may be disclosed to interested third parties if necessary.

Unless otherwise agreed, the Parties agree that each of them shall independently bear its own costs related to the tasks provided for in this Memorandum.

All changes and additions to this Memorandum shall be made in writing and by agreement of the Parties.

## 4. FINAL PROVISIONS

The relations of the Parties, which are set forth in this Memorandum, are exclusively relations of independent parties.

Each Party has the right to cooperate with a third party on any issues similar to those provided for in this Memorandum.

All disputes regarding the interpretation and application of the provisions of this Memorandum will be resolved through diplomatic negotiations and consultations between the Parties.

This Memorandum enters into force from the date of its signing and remains valid until 2027.

The termination of the Memorandum shall take effect three months after written notification by the relevant party. Thereafter, the Memorandum shall cease to be valid, except for the settlement of claims arising prior to the date on which the Memorandum ceased to be valid, as well as any ongoing activities for the implementation of specific projects within the framework of this Memorandum.

The text of the Memorandum is drawn up in 2 (two) copies in the Ukrainian and English languages, 1 (one) copy for each of the Parties, while all copies have the same force.
